In accordance with Bill 98 – *The Better Schools and Student Outcomes Act, 2023*, the following guidelines provide the expectations with respect to third party speakers or groups in schools.

#### **A. Who the guidelines apply to**

These requirements apply to all school events that take place during the school day whether organized by the school or by system staff that:

- involve a third-party speaker or group (e.g. guest speakers, live performances); - are organized by a school, a department, a teacher or other staff member, including system staff, Catholic School Council or a student group; and
- that involves all students in a school, or students in multiple classes.

#### **B. Requirements for sharing with parents and guardians**

Information must be shared at least 14 calendar days in advance of the planned event through EDSBY and on the individual school website.

Note: if at any time, there is a change to a planned event or should arrangements at the school level not allow for 14 calendar days advance notice such as a change in speaker, limited planning time, the school is required to provide the information to parents/guardians as soon as final arrangements are finalized.

The notice must include:

- date and time of the activity;
  - name(s) of the guest speaker(s) and the organization they represent, if any;
  - title and location of the activity, together with the names of the presenters or performers; - topic or focus of the activity;
  - connection to the curriculum and/or the purpose of the activity; and
  - details of any handouts, materials, giveaways, or literature provided.

Note: Schools are permitted to exclude certain information, such as date and time of the activity, where the school board determines that publicly posting this information would pose a safety risk to students and/or staff.

Principals or designates are to contact the school assigned Superintendent of Education in the event that further clarification is required with respect to these administrative procedures and guidelines.
